The Government of Republic of North Macedonia has received a Soft Loan from the Italian Government to Supply of Medical Equipment within the “Rationalisation of Managing and Modernisation of biomedical technology in the Health Sector Program” and intends to apply part of this Soft Loan to cover the costs of the Contract for „Purchase, delivery, installation, commissioning and training of Hospital and Health centre equipment,, to a maximal amount of **Euro 1.070.000.**
2. This procurement is divided in the following lots:

Lot 1 - Dedicated MRI:

1. Dedicated MRI for musculoskeletal(MSK) imaging, weight bearing and Neuro imaging head – 1 piece
2. Dedicated MRI for extremity imaging – 1 piece

TOTAL BUDGET:770.000 Euro

Lot 2 – Ultrasound devices:

1. Ultrasound for gastroenterohepatology– 1 piece
2. Ultrasound cardio- adult– 1 piece
3. Ultrasound for nephrology– 1 piece
4. Interventional ultrasound– 1 piece
