1. Tender dossier, Part A - Instructions to tenderers, Article 2 – Timetable, has been changed:

2. Tender dossier, Part A - Instructions to tenderers, Article 3 – Participation, has been changed, Point 3.6 is added and says:

*"All natural and legal persons legally established in the Republic of North Macedonia are allowed to participate in this Tender, provided that:*

- Are authorized by the manufacturer of the goods from the Republic of Italy to take part in this Tender,*
- Offers equipment originated / made in the Republic of Italy (as defined by Part A – Instruction to tenderers, Article 4.Origin, Point 4.1.),*
- Are able to prove - to the satisfaction of the Contracting Authority - that they comply with the necessary legal, technical and financial requirements and have the wherewithal to effectively carry out the contract (as defined by Part A – Instruction to tenderers, Article 3. Participation, Points 3.2; 3.3; 3.4 and 3.5),*
- Are able to provide all documents listed in Part A – Instruction to tenderers, Article 11. Content of tenders".*

3. Tender dossier, Part A - Instructions to tenderers, Article 10 – Submission of tenders. Point 10.3 has been changed and states as follows:

*"All tenders must reach the Ministry of Health, 50 Divizija14, 1000 Skopje, Republic of North Macedonia – Archive Department, by 23.09.2021, 12:00 (Rome*

*Time). They shall be sent by means of a registered letter with acknowledgement of receipt or hand-delivered against receipt signed by the Project Manager or his Representative."*
